Application for ACC Breedable Registration and Pedigree

American Coton Club Breedable pedigree/registrations are only issued to ACC Code of Ethics Breeders. Application for Breedable status may be submitted for a Coton de Tuléar older than one year of age that has passed required ACC health tests. Please attach a copy of either your Coton's pedigree or the pedigrees of both sire and dam. At this time ACC can only accept pedigrees from USACTC, CTCA, AACDT, FCI, CFC or (UKC where the ancestry can be verified). Other registries will be reviewed on a case by case basis.

ACC COE breeders are required to register their Cotons and litters with the ACC, and to register their breedable dogs as Breedable Quality after submission of health test results after reaching one year of age. All offspring produced shall be registered with the American Coton Club and shall have ACC health test certified parents, and a litter registration for the offspring must be on file with ACC.

Health Test Requirements - A CERF (an eye exam by a certified veterinary ophthalmologist) is required and must be viewable online in CERF's database (<http://www.vmdb.org/verify.html>). A minimum of two more certified tests are also required from the following list: OFA Patella, OFA Cardio, OFA Thyroid, OFA/PennHip Hips, OFA Elbows, full blood chemistry with CBC. All OFA results must be viewable online in OFA's database (www.offa.org). Please attach the results of any other health tests completed.

There is a \$50 fee if the Coton does not have a current ACC provisional/show pedigree. The breedable pedigree is free if the owner has a current ACC provisional/show pedigree and the owner is an ACC COE Breeder.
