15. Are you amenable to answering questions that may arise in the future about your particular breeding situation and responding to constructive criticism without rancor?
16. If circumstances change in the future and it appears that ACC is not the best fit for you as a breeder, are you amenable to leaving the ACC COE Breeders list upon the recommendations of the ACC Board?
17. New breeders may sell provisional/show (formally referred to as "potentially breedable") from their first litters only upon the advice of their Mentor. Do you understand this and agree to sell your puppies as companions on a spay/neuter contract?
